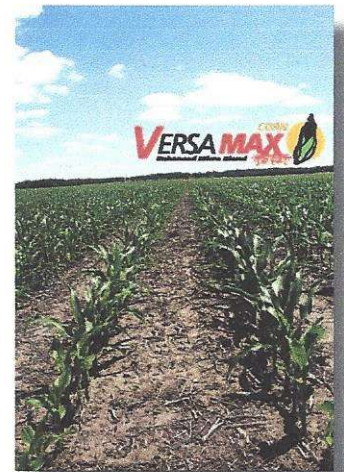

GENERAL INFORMATION

VERSA MAX-Corn is a dynamic mixture of macro & micronutrients that can be applied in a versatile manner - as a foliar application or in row starter/side dress applications. VERSA MAX-Corn is designed for use in corn, but can be used in other food and fiber crops that have similar nutritional requirements.

APPLICATION RECOMMENDATIONS

VERSA MAX-Corn is intended to be used as a supplement to a standard fertility program. VERSA MAX-Corn, used according to the following recommendations, will improve plant health by providing efficient delivery of nitrogen (N) and essential micronutrients (S, Fe, Mn, Zn) as part of a total fertility program that will decrease plant stresses and increase potential for maximum genetic expression of crops.

Foliar Applied:

Apply 1 to 2 quarts/acre prior to or immediately after nutrient deficiency symptoms occur to prevent further yield loss potential. For ground applications use a water carrier volume of 10 GPA minimum or 5 GPA for aerial applications. In severe nutrient deficient crops, a second application should be made two weeks after initial application.

TANK MIXING INSTRUCTIONS WITH PESTICIDES

1. Fill tank ½ full of water.
2. Add AMS based water conditioner adjuvants and other tank mix adjuvants (as needed), agitate.
3. Pour in desired rate of VERSA MAX-Corn, continue agitation.
4. Add pesticides per label, continue agitation.
5. Finish filling tank.

Soil Applied:

Apply 1 to 2 quarts/acre - Most effective results are obtained when VERSA MAX-Corn is applied in row starter fertilizer at the time of planting.

TANK MIXING INSTRUCTIONS WITH FERTILIZERS

1. Fill tank at least ½ full of liquid fertilizer.
2. Pour in desired rate of VERSA MAX-Corn while agitating.
3. Finish filling tank with liquid fertilizer with agitation running.
4. If needed, add other chemicals after the VERSA MAX-Corn - fertilizer mix has been prepared.

NOTES

All micronutrient blends can potentially antagonize pesticides and tank mixes. Consult all tank mix product labels prior to adding VERSA MAX-Corn to tank.

STORAGE & DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Product may suspend in layers if stored below 20°F.

Triple rinse (or equivalent) prior to disposal. Add rinsate to tank. Offer container for recycling or dispose of properly according to state and local authorities. If burned, stay out of smoke.
